The 6<sup>th</sup> annual community garage sales will be May 9-11. This is for anyone who has a city water bill

Arbor Day Celebrations are coming up. On April 26, 2024, at 10 a.m., there will be a Crimson Maple tree planted at Willard Schools in honor of the late Coach Terry King.

On April 29, 2024, the City of Willard had been selected by ODNR for their 75<sup>th</sup> Annual tree planting. The tree will be planted at the Willard Reservoir.

Next week is hydrant flushing. Remind residents if they see their hydrant being flushed don't do laundry for a day or two. Anyone with private hydrants can call the city and they will teach you how to properly flush your hydrant.

Springfest is Saturday May 11, 2024. There will be touch-a-truck, bike rodeo, pickleball tournament, and vendors. This is a nice kickoff to warmer weather.

Resolution to participate in ODOT salt bid. Their price is \$49.93 per ton for Huron County for 2025. Going to commit to 150 tons.

Mowing season is upon us. City ordinance states the grass can't be higher than six inches.

The Maintenance Department continues to be busy. They have sent workers to classes for continuing education.

They have also removed a broken hydrant, replaced street signs, repaired curb boxes, installed water taps, and started mowing.

Columbia Gas is back in town. We ask if anyone has any complaints about work that they did last year please give the city a call.

Had a preconstruction meeting last week, on the Willard Water Plant Project. The engineers were there along with Moser. The construction should start in June. We started talking about this in 2018.

The council was asked to accept donations.

The following was donated to the Sesquicentennial Fund \$10,000 from United Fund of Willard, \$1,000 from Willard Volunteer Firefighters Association, \$500 from an anonymous donor, \$3,010.32 from the Willard Moose Lodge. The President of Council requested a motion to accept the donations. Moved by Olson, seconded by Babcock. In a vote called therein Babcock, Danhoff, Daniel, Elmlinger, McKenzie, Olson, and Sattig, voted yea. Motion carried.

There has been nearly \$62,000 donated or pledged to the Sesquicentennial Fund.

# PRESIDENT ASKED FOR QUESTIONS:

McKenzie asked what type of tree ODNR is planting at the reservoir. Not certain of what type of tree but it will be planted close to the pavilion.

Elmlinger asked if we have room to store all the salt. We don't have to purchase salt until May of 2025. This just locks in the price. We are obligated to buy 150 tons.

Babcock congratulated Cody Hacker for getting certified in underground storage.

We got a BCI grant to purchase the drones. Ryan Gillmor runs the drones and contacted the EMA for the sniffer. The drones help with fires and lost people, we have two drone operators in town. You have to have a federal license and every time a drone goes up the flight must be recorded.

Thanks to Ryan Gillmor for helping to find a suicidal man in Fitchville.

McKenzie and Elmlinger thanked the police department for upholding the city and state laws.
