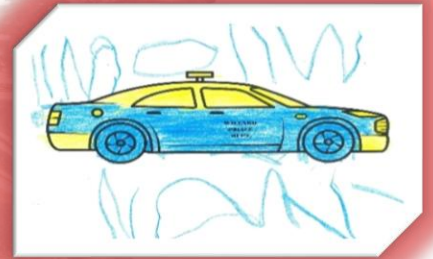
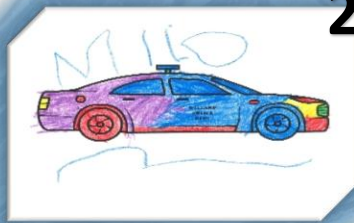

Message from Chief Shannon Chaffins

The 2020 Annual Report is submitted for your review.

The year 2020 has been full of challenges. The coronavirus pandemic has put numerous limitations on the police department. The Black Lives Matter movement and calls for police reform throughout the country have brought racism and police misconduct to the forefront of our minds. I am pleased to report that throughout all these national events, the Willard Police Department has had the pleasure to maintain constant support from our citizens. The constant flow of small gifts, smiles and waves, thank you's, and encouragement, is a constant reminder of the great community we serve. The drawings on the cover of this report are example of what is sent to our department on a regular basis.

This year, two of our officers chose to leave the department to pursue careers in other professions. With these resignations brought opportunities for others to join our department. Amanda Brown joined our dispatch staff to replaced Danielle Rohrbach, who was moved to road patrol. Jordan Vanichek, who works full-time as a PST at the Erie County Sheriff's Office, joined our department on a part-time basis. Courtney Burkett has also joined our department as an officer. We are pleased to have our new employees aboard and look for great things from them.

Despite all these challenges, we have continued many community programs. Officer Tackett has continued his SRO and DARE duties, although on a limited basis. Officer Slone's senior watch has continued to be appreciated by the participants and their families. Many other officers have stepped up and participate in the senior watch checks as well. Vacation and extra patrol requests are checked on a regular basis.

Although there have been setbacks on the national front, crime in the city has continued to diminish over the last few years. You will see in the pages that follow a continued downward trend in property crimes. For example, from 2018 to 2019, we experienced a 38% drop in



vehicle break-ins (73 in 2018 and 45 in 2019), followed by another 51% drop from 2019 to 2020 (23 vehicle break-ins in 2020). Willard Police Department personnel continue to hold each party responsible for their crimes in a prompt and professional way.

Community and city council support has been the foundation of the police department's success. Thank you for your continued support of those who have "boots on the ground" and for those that make this community the best that it can be.

2020 Call for Service Highlights

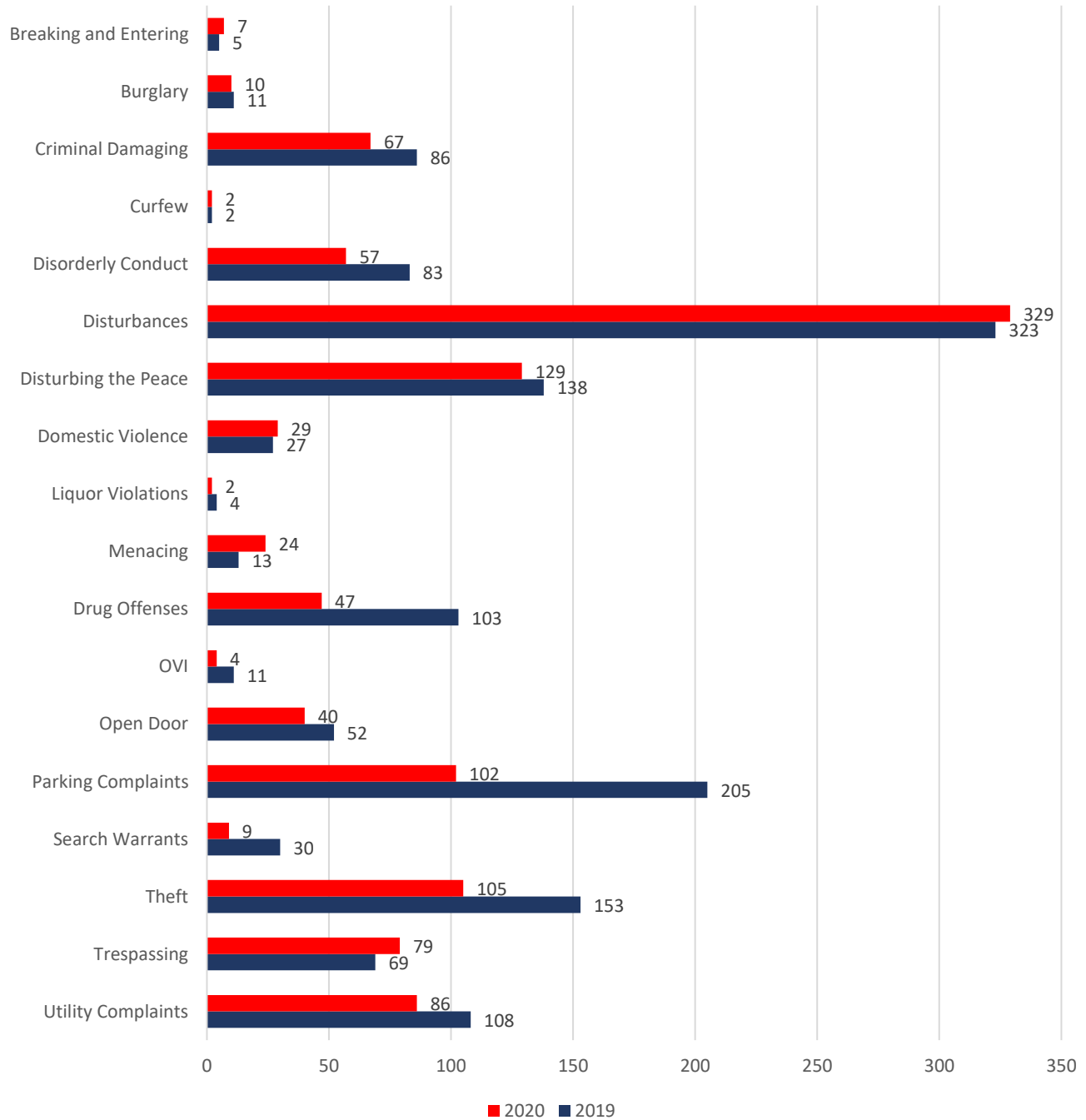
- **January 24th** – Officer Slone and Officer Salazar respond to an overdose call on Motson Street. Officers find a small amount of suspected fentanyl near the victim. The male subject is taken to Willard Mercy Hospital for treatment, and then the Huron County Jail for drug charges.
- **February 23rd** – Officer Poggiali and Officer Malson respond to a 911 call on Rae Court. The caller initially cannot speak to the dispatcher but leaves the telephone line open so the dispatcher can hear what is occurring. As the suspect leaves, the caller advises dispatch that an assault occurred. This information is relayed to officers, who locate the suspect in the parking area. The suspect refuses orders given by Officer Poggiali and Officer Malson. Officers call for assistance from other agencies, and several officers from the Ohio State Highway Patrol and the Huron County Sheriff's Office arrive. The suspect eventually surrenders and is arrested for Domestic Violence and Resisting Arrest and taken to the Huron County Jail.
- **March 11th** – Sergeant Gillmor and Officer Weiss respond to a burglary in progress on Keefer Street. Several items were found to be missing from the residence. Detective Gilliam and Sergeant Gillmor develop a suspect, who is arrested later that day for Aggravated Burglary.
- **April 27th** – Sgt. Mahon takes a stolen vehicle report from a Ridgewood Drive resident. Sgt. Mahon's investigation reveals two suspects, who are later arrested and transported to the Huron County Jail. The suspects are charged with Grand Theft and Receiving Stolen Property. The vehicle is also recovered.
- **May 29th** – Officers respond to an assault in progress on W. Tiffin Street. Officer Hall and Officer Salazar arrest a male subject for Assault, Disorderly Conduct, and Criminal Damaging.
- **June 24th** – Sgt. Mahon, Officer Salazar, and Officer Rohrbach are dispatched to an assault on St. Mary's Street. Upon arrival, officers learn that a male subject had broken into a home and assaulted the owner. The offender is believed to be armed with a handgun. Willard Police units, Ohio State Patrol, and the Huron County Sheriff's Office set up a perimeter surrounding the area where he is believed to have fled. The offender is apprehended shortly thereafter on Spring Street. A handgun is also recovered during a search of the area where the suspect was apprehended. The suspect is transported to the Huron County Jail on multiple charges.



- **July 14th – Officer Salazar and Officer Poggiali respond to multiple 9-1-1 calls from a male subject, determined to be residing on Keefer Street. Officers arrest the male subject for Disorderly Conduct/Intox and Misuse of 9-1-1. The male subject is transported to the Huron County Jail.**
- **August 10th – Sgt. Mahon is dispatched to W. Pearl Street for a suspicious male subject. Sgt. Mahon determines the male subject had broken out several windows to a residence. The male subject is transported to Willard Mercy and charged with Criminal Damaging.**
- **September 5th – Officer Salazar and Officer Poggiali are dispatched to an assault at the Willard Country Inn. Officer Salazar locates the suspect nearby. The suspect is ultimately charged with burglary, assault, and resisting arrest.**
- **October 9th – Officer Salazar and Officer Poggiali are dispatched to a disturbance on S. Myrtle Avenue. Officers locate an involved male subject, who is arrested for Disorderly Conduct. The male subject resists arrest and kicks officers. The male subject is charged with Resisting Arrest and Assault and transported to the Huron County Jail.**
- **November 20th – Officer Reel responds to a disturbance at Wendy’s restaurant, in which a fired employee had assaulted the manager. The former employee flees the restaurant before officers arrive. Officer Reel and Sgt. Mahon locate the suspect, who is arrested and transported to the Huron County Jail on charges of Burglary and Assault.**
- **December 6th – Officer Weiss and Officer Reel are dispatched to a Spangler Street residence in which a male subject broke into the back door and pointed a gun at the residents. Officers locate the male subject inside the residence, along with the gun used in the crime. The male subject is transported to the Huron County Jail for multiple offenses.**



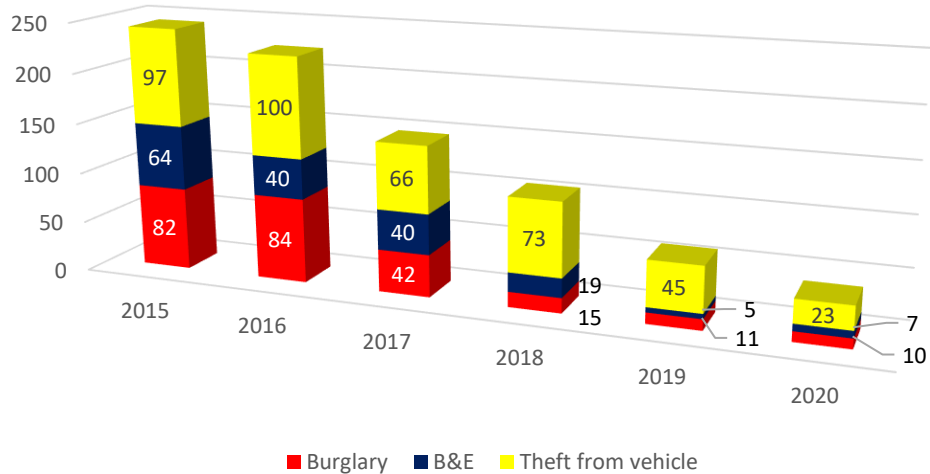
Call for Service Type Comparison, 2019-2020



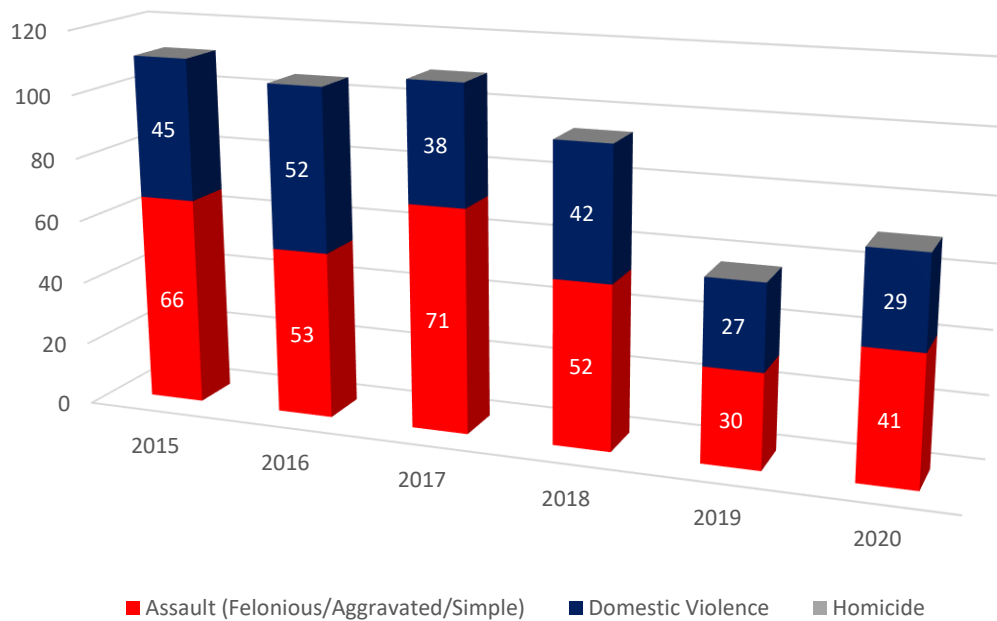


Theft Offense Statistics and Violent Offense Statistics

Theft Complaints, 2015 - 2020



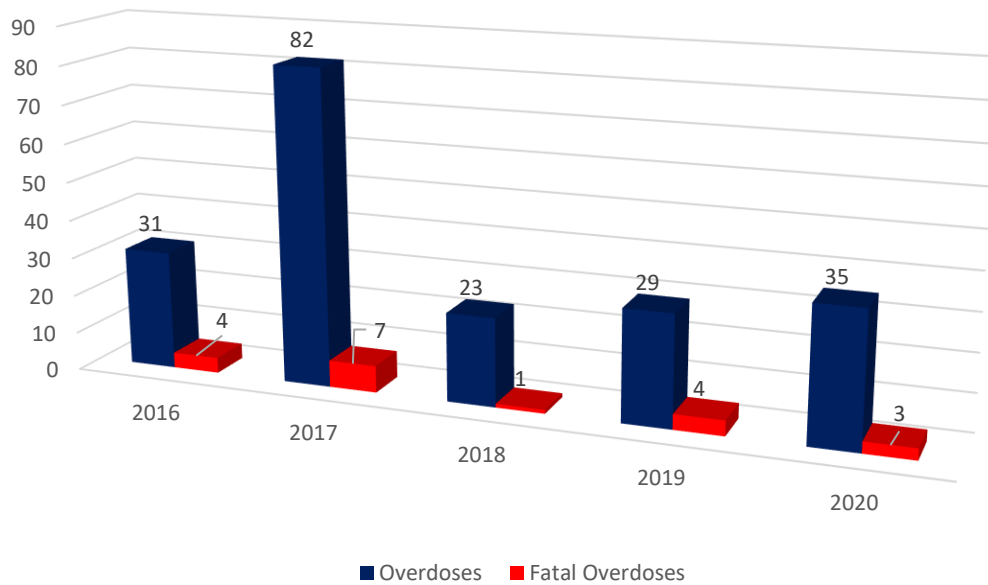
Violence Complaints, 2015 - 2020



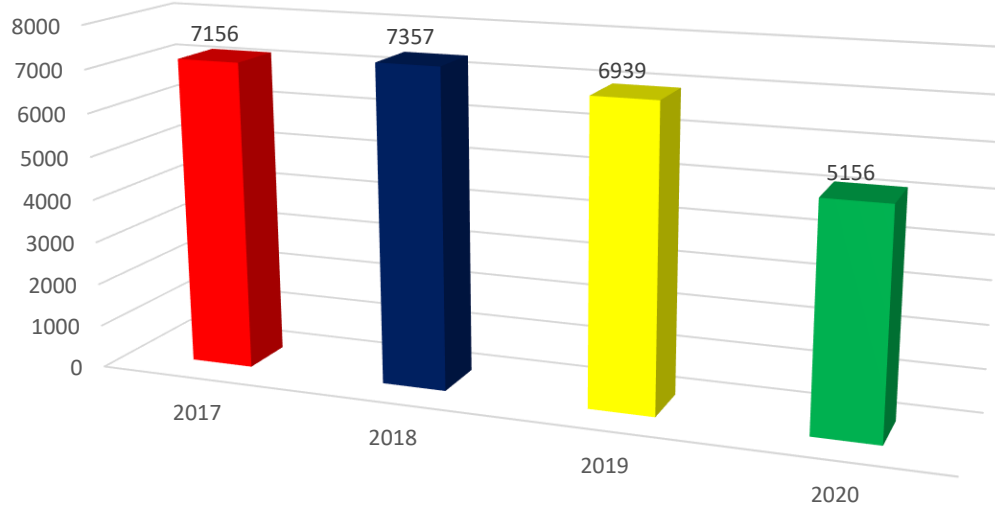


Overdose and Total Calls for Service Statistics

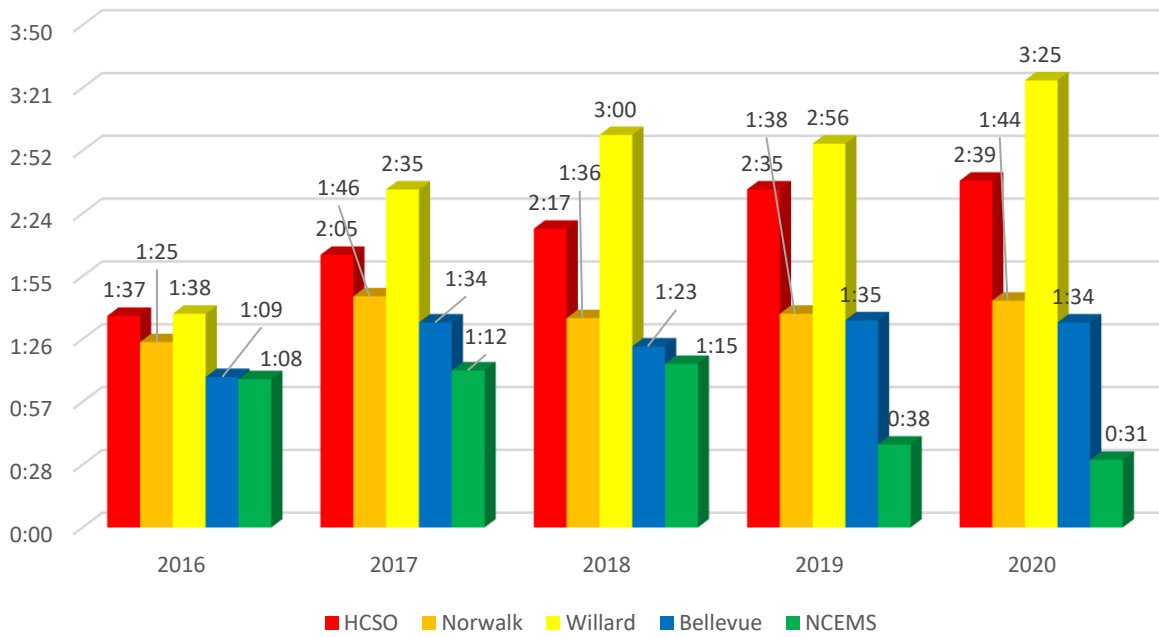
- Willard Police Department Public Safety Telecommunicators (PST) and Emergency Medical Dispatchers (EMD) handle emergency and non-emergency calls for Willard Fire/EMS, Willard Police Department, and other city departments during non-business hours.
- Willard Police Department PSTs handle phone calls and radio traffic from the Willard Fire Department Fire District, which is approximately 92 square miles and serves approximately 12,500 people.
- The Willard Police Department dispatch center is manned 24/7 with only PST/EMD certified personnel, including 4 full-time Dispatchers, 1 part-time Dispatcher, 2 Officers, and 1 Sergeant.
- Willard Police Department PST/EMD duties include, but are not limited to:
 - Man 2 lines of 9-1-1 and 3 non-emergency lines
 - Provide walk-in assistance and customer service
 - Prioritize proper responses for multiple requests simultaneously
 - Compile a variety of information and records, including domestic violence reports, annual reports, monthly reports, parking enforcement, etc.
 - Monitor the jail and prisoners
 - Monitor the police department, city hall, downtown, and recreational department surveillance cameras
 - Enter, maintain, and validate warrant entries, inquiries, and teletypes through LEADS (Law Enforcement Automated Data System)
- Training attended by Willard PST/EMD include:
 - LEADS TAC (Technical Agency Coordinator) In-Service training
 - LEADS Assistant TAC Training
 - Police Legal Science (PLS) online monthly training
 - 2020 Ohio NENA (Virtual) Conference for several training sessions

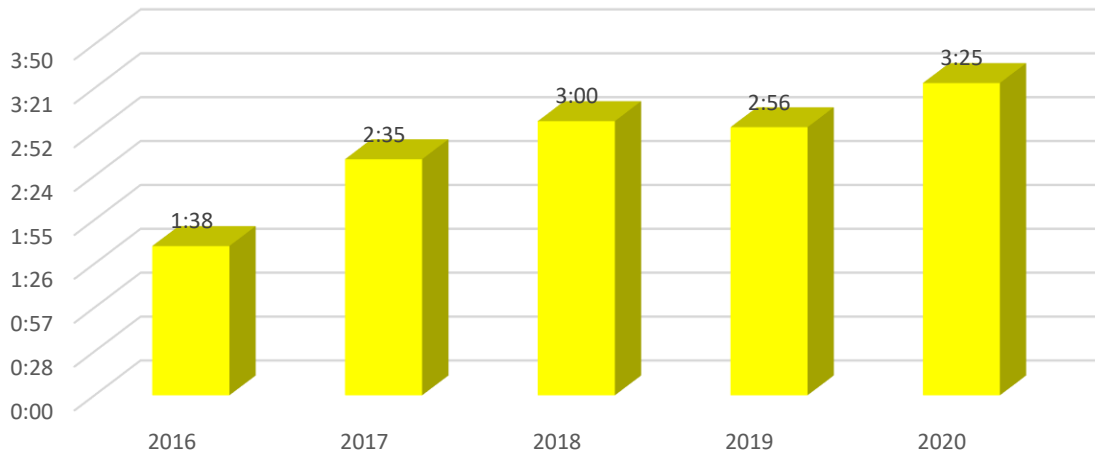


Dispatch Statistics

9-1-1 Average Call Time in Minutes, Per PSAP



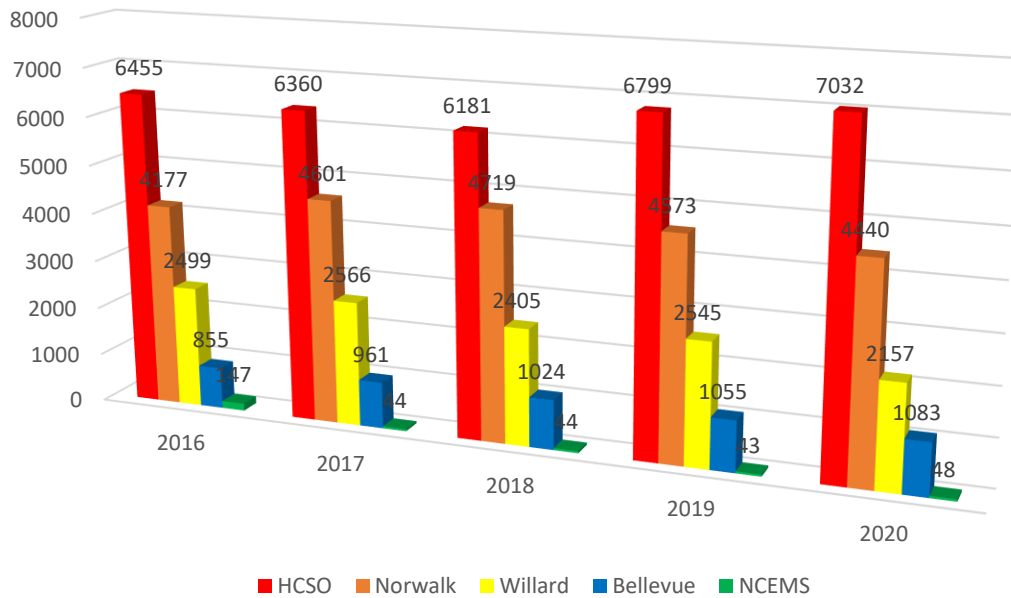
9-1-1 Average Call Time (Willard Dispatch Only)



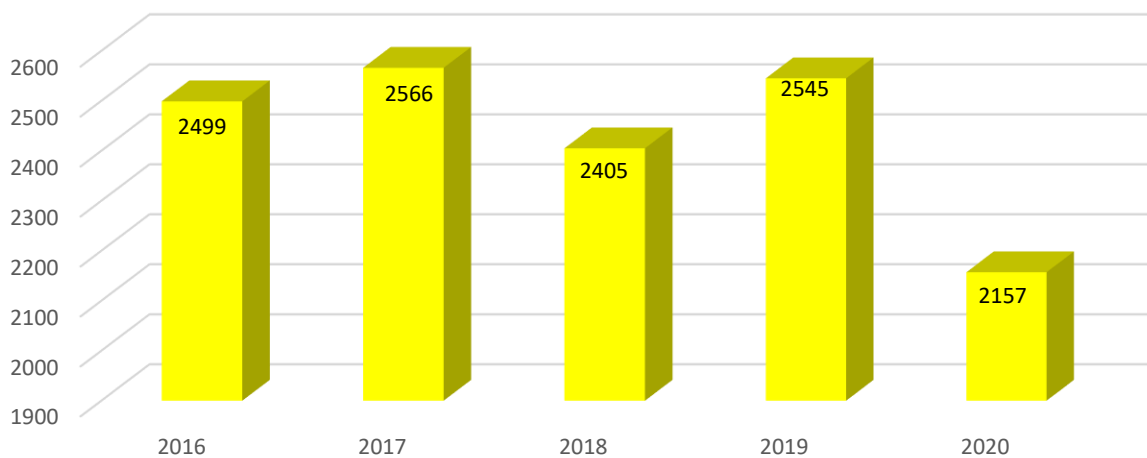


Dispatch Statistics (continued)

Incoming 9-1-1 Calls to Willard PD

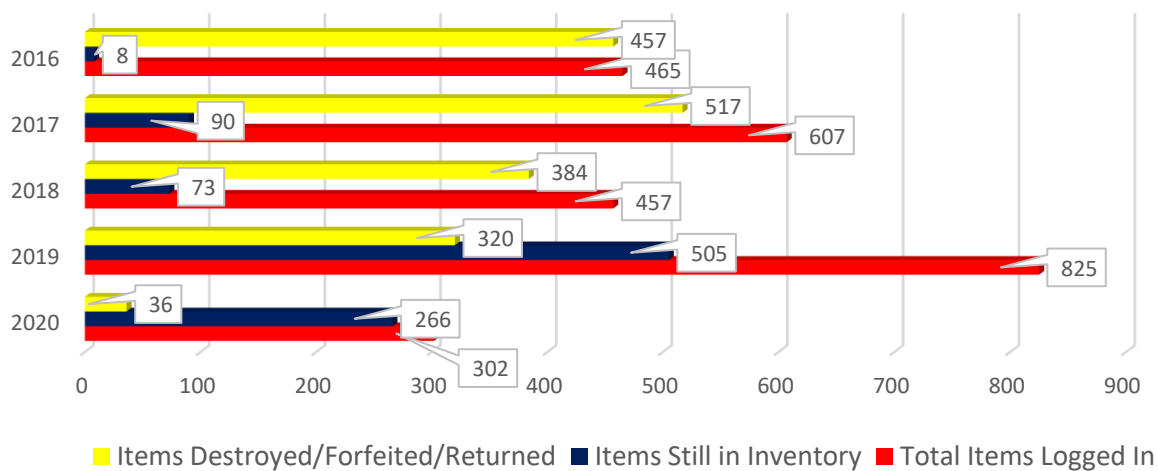




Willard Police Department Evidence Room Report

Evidence Room Submissions, Returns, and Items Destroyed



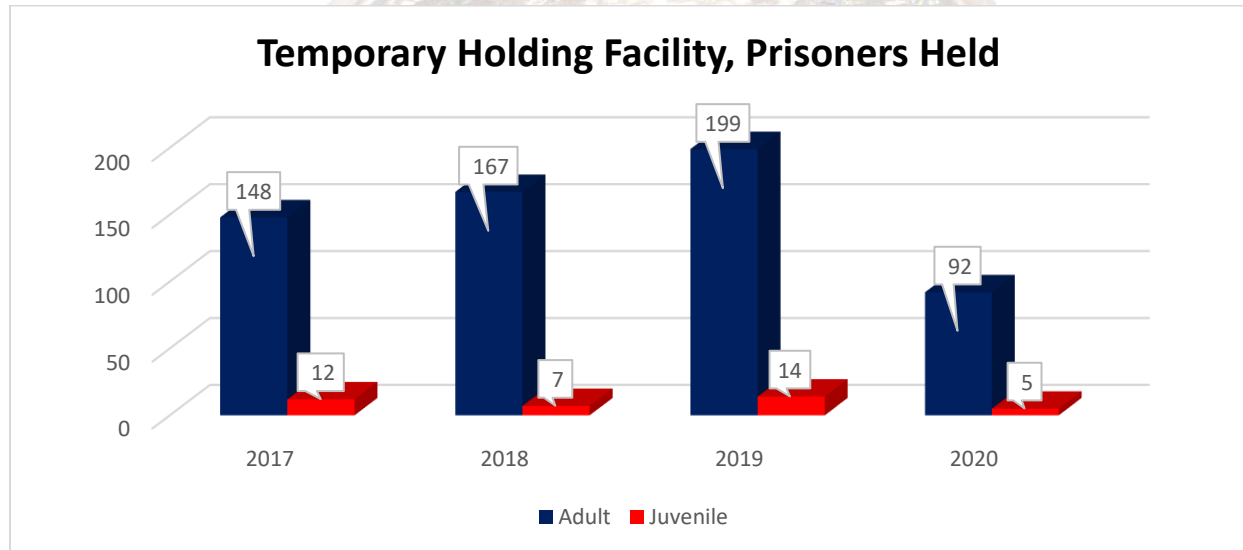
- At the end of 2020, the evidence room holds a total of 1,156 items.
 - At the end of 2019, the evidence room held 1,338 items.
- These items include drugs, related drug paraphernalia, money, guns, sexual assault kits, and any other items that officers deem necessary to keep, to aid in prosecuting criminals.
- Most items are only disposed of by court order. Some items are ordered by the court to be forfeited to Willard PD, including money and guns.
- Evidence disposals are held at least once a year.
- In cases of serious crimes, items are required to be kept indefinitely.
- Because of this, some items that are still in inventory date back to 1999 or later.
- The evidence room is fully inventoried twice per calendar year.
- All items are present and accounted for.

- The Willard City Jail is used to hold prisoners up to (6) hours at a time.
- The above numbers do not reflect the number of arrests due to the following circumstance:
 - Many arrestees are not brought to the city jail, but instead transported to the Huron County Jail directly from the arrest location.
- The Ohio Department of Health inspects the city jail on an annual basis.
- The Willard Fire Department inspects the city jail on an annual basis.
- Juvenile offenders are sometimes held in the jail for occasions when they are combative or a flight risk. Most juveniles are held in the police lobby until arrangements can be made for transport to a detention facility or released to their parents or guardians.
 - Juveniles detained in the temporary holding facility are logged separately and are reported to the Ohio Department of Corrections on a quarterly basis.
- Combative and/or suicidal prisoners are sometimes held in a restraint chair.
 - Policy dictates that prisoners in the restraint chair are to be monitored throughout their incarceration.

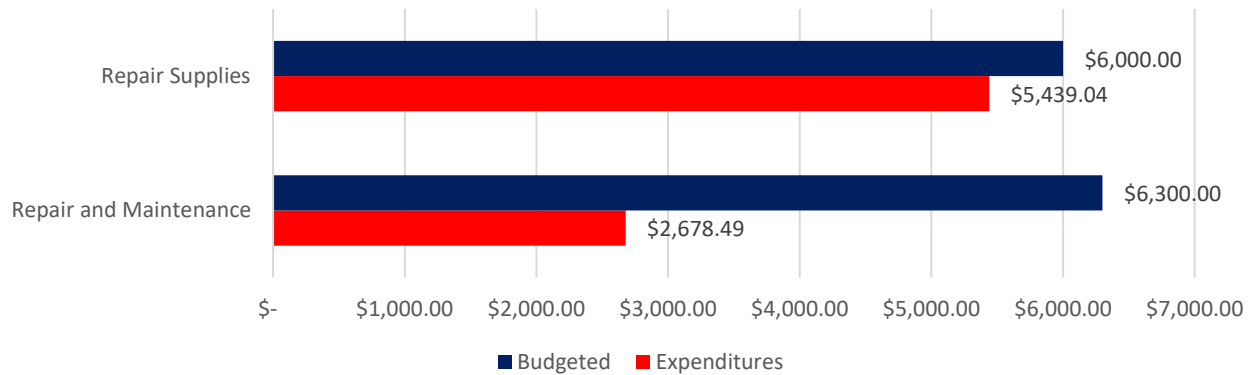

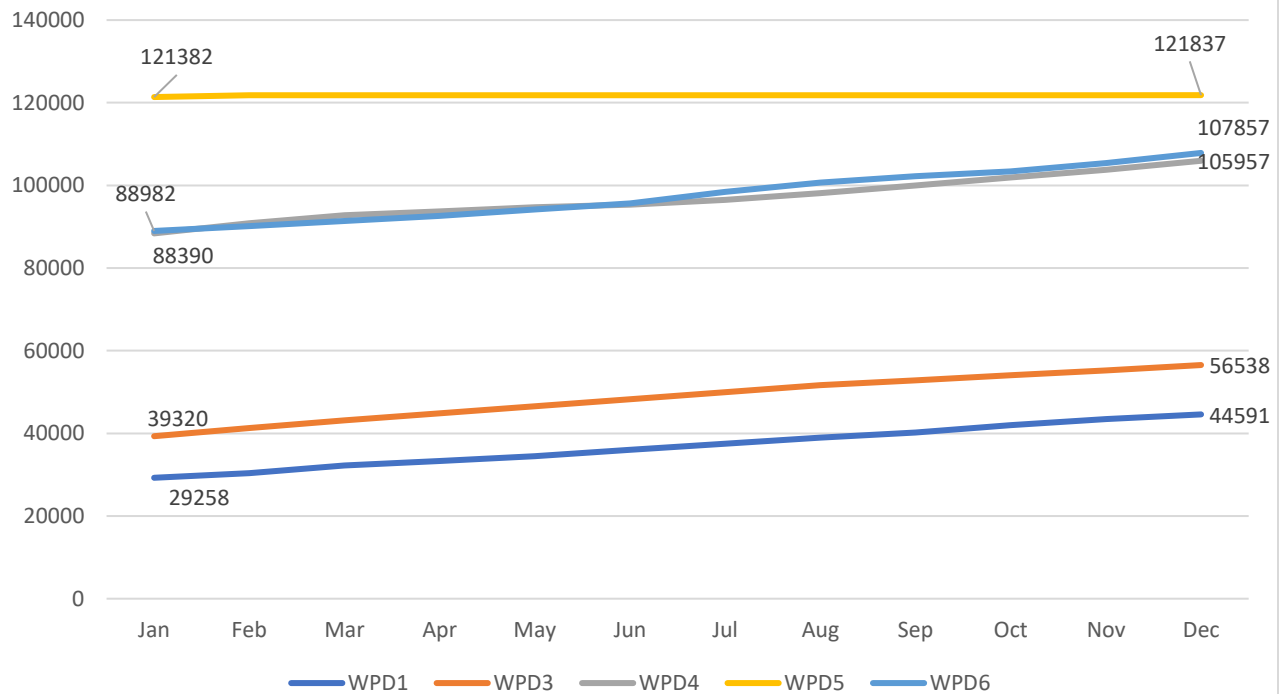

Juvenile Officer Report

The COVID Pandemic that took place in 2020 no doubt greatly affected the Juvenile Office. The juvenile officer was restricted in participating in the Willard Schools Mentoring Program, High School Drone Club, and Bicycle Safety Awareness. The COVID Crisis also resulted in the cancellation of the 46th Bicycle Rodeo, the touch-a-truck event, as well as the youth driver course presented by AAA. The overall Juvenile complaints and juveniles dealt with increased in 2020 compared to last year. The most notable increase was the unruly juvenile category. The increase could most likely be attributed to the fact that children were home more because of the remote learning protocols. The juvenile officer worked closely with Huron County Children Services, the school resource officer, and the detective by assisting with numerous investigations involving minors. The juvenile officer was a member of the multi-disciplinary team involving the Child Advocacy Center which is used for interviewing child victims. The team conducted case review meetings remotely this year. One highlight was the presentation of the Eddie Eagle Gun Safety Program to all 125 3rd grade students at the Willard Elementary School in January.

2019 Mobile Forensics Report

The Willard Police Department processed various mobile devices for a variety of different cases and agencies. The most prevalent mobile devices analyzed in 2020 were a result of narcotics investigations including overdose and trafficking. The department was provided equipment purchased by the Huron County Prosecutor's Office and the METRICH Drug Task Force. This included the licensing of specialized software. Having the equipment onsite enabled evidence to be processed within hours and days instead of weeks and months. This also enabled the department to have a collaborate response and effort to handling investigations with other agencies in the county. I received specialized training from the United States Secret Service - National Computer Forensics Institute on mobile device examinations as well as have maintained certification from the vendor, Cellebrite. The fact that most crimes involve the use of mobile devices justifies the need to be able to quickly process them in a timely and efficient manner.

Through 2020 Willard Detectives worked a variety of investigations. This is a small synopsis of some of those investigations:

- **January 2020:** Willard Police Department took a report and arrested a male for Domestic Violence. A subsequent investigation led to the seizure of narcotics, 4 firearms (1 had been reported as stolen), and \$1753.00 from a safe which was located inside the residence.
- **Also in January 2020,** Willard Police investigated a fatal overdose that occurred at a Willard residence. The overdose led to another criminal investigation involving the property owner of the residence.
- **February 2020:** Willard Police Department performed an investigation that led to charges including Attempted Felonious Assault, Attempted Kidnapping, and Menacing



by Stalking. This investigation began when a local employee found a threatening note on his vehicle when he left work. During the investigation it was revealed that the suspect had taken extreme measures to ensure he would not get caught for the crime including purchasing an undocumented firearm, researching how to defeat security systems, and searches were even done about how to chemically dispose of a dead body. Ultimately the suspect was located and arrested by Detective Gilliam and Detective Evans (Huron County Sheriff Department) for the crimes prior to him being able to fulfill his plans.

- **March 2020:** Willard Police investigated a Burglary incident in which a female woke to a male rummaging through items in her bedroom closet. The suspect was apprehended later that day after being located in a Huron County residence and charged with Burglary and other charges related to the incident. This same suspect was also charged for his involvement of a recovered stolen firearm in January 2020 as that investigation was still ongoing at that time.
- **April 2020:** Willard Police Department took a report of a stolen vehicle. The investigation led to 3 search warrants being executed simultaneously with the assistance of numerous Huron County, Ohio State, and Federal agency personnel. During the execution of the search warrants 167 vehicles, 2 residences, 2 businesses, and several other storage facilities were searched, which led to another stolen vehicle being discovered at a Huron County business just outside of Norwalk. Other items were seized as part of the crimes including firearms and 2 commercial vehicles.
- **May 2020:** Willard Police Department responded to a call of a juvenile who had just been struck by a vehicle while on the sidewalk. This led to an adult being located the next morning in another town and charged with vehicular assault for her admitted involvement in the incident.
- **June 2020:** Willard Police responded to a call in which an 80 year old resident was attacked in his home. During the incident the suspect fought with the resident and fled the residence with the victim's firearm. The suspect was located and arrested a couple hours later with the assistance of a tip from the public about him attempting to escape a perimeter that was set up to contain him. The suspect was charged with numerous charges including Aggravated Burglary and later sentenced to 8 years in prison.
- **July 2020:** A resident of Willard was involved in an unfortunate accident that led to him being in a coma for over a month. During this time it was discovered that the elderly male was being victimized by an individual for a large amount of money.



Huron County Prosecutor's Office assisted in the investigation which led to a suspect being charged with numerous offenses including Burglary, Fraud, Theft, and other charges.

- **August 2020:** Willard Police located a suspect who had unlawfully taken up residence in the house of the same victim of the July incident referenced above. This suspect was charged with Burglary since the victim who was still in a nursing home did not allow him to be in the residence.
- **December 2020:** Willard Police Department was contacted by a local business about an employee who had stolen items totaling over \$42,000 from them. The suspect admitted her involvement in the theft.
- **December 2020:** Willard Police responded to a narcotic overdose at a residence. Further investigation into the incident led to a search warrant being executed on the house later that day, and the occupants were later charged with several Felony charges related to their involvement in narcotic trafficking from the residence.

Other notable events in 2020 that the Willard Detective Bureau took part in include:

- In 2020 Sgt. Gillmor and I assisted The Huron County Sheriff's Department and Norwalk Police Department with executing several search warrants. I also had the opportunity to work with members of the Attorney General's Office, Secret Service, FBI, BCI, Postal Inspectors, Ohio License Bureau Investigators, Homeland Security, as well as countless individuals from other Law Enforcement agencies with investigations over the last year. The partnership between other agencies is invaluable for details like search warrants and other incidents that require knowledge and experience that each agency is able to provide each other. I also assisted the U.S. Marshals on many dates in searching for violent offenders throughout North Central Ohio.

This year presented many hurdles that we had to overcome to continue to enforce and investigate some of the typical criminal activity. This led to an "outside the box" approach to some situations which ultimately gave more experience on different approaches to combat criminal behavior thus making each officer a stronger investigator.

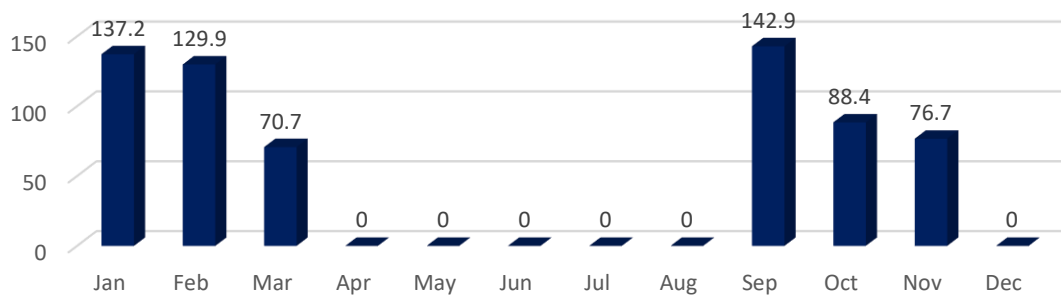

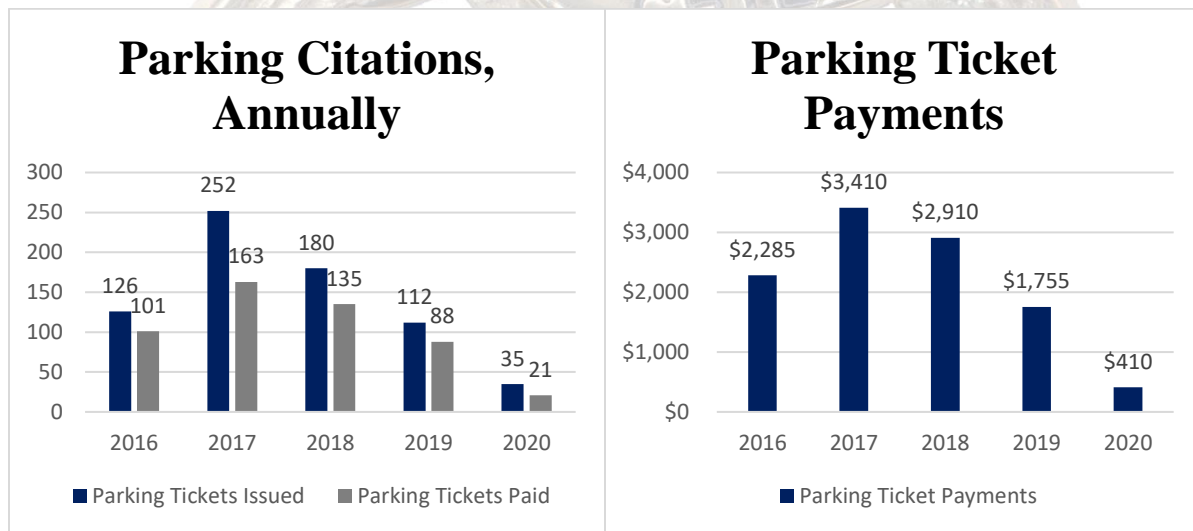

- 35 parking tickets were issued in 2020
- 25 of those 35 (71%) have been paid as of 12/31/20 for a total of \$410.
- Income decreased by 77% from 2019 to 2020
- 10 tickets were sent to collections in 2020
 - 10 (100%) are still outstanding
- As of 12/31/2020 there are 158 tickets with collections totaling \$10,080

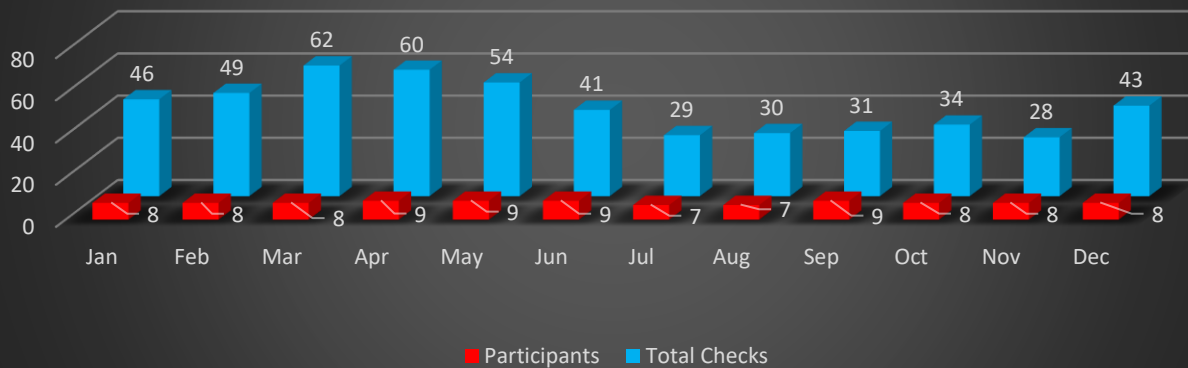


Community Programs

Senior Watch

- The Senior Watch Program was initiated by Officer Brian Slone in 2017
- Senior Watch offers weekly checks on senior citizens by officers to ensure their safety
- This year, there has been a total of 507 Senior Watch checks completed by various officers

Extra Watch and Patrol

- Citizens may request the police department check on their residence periodically throughout the month
 - These checks are put into (3) categories: vacation checks, vacant residence checks, and extra patrol requests
- Local business owners may also request extra checks on their business
- Computer software enables officers to look at these requests directly from the patrol car
- Officers look for open/unlocked doors, windows, and any other security concerns
- If any security concerns are observed, officers notify the designated contact person
- In 2020, Officers logged a total of 4,435 checks on a total of 289 extra watch and patrol requests
