## ORDINANCE NO. 5970-24

AN ORDINANCE APPROVING THE EDITING AND INCLUSION OF CERTAIN ORDINANCES AS PARTS OF THE VARIOUS COMPONENT CODES OF THE CODIFIED ORDINANCES; PROVIDING FOR THE ADOPTION OF NEW MATTER IN THE UPDATED AND REVISED CODIFIED ORDINANCES; PROVIDING FOR THE PUBLICATION OF SUCH NEW MATTER; AND REPEALING ORDINANCES AND RESOLUTIONS CONFLICT THEREWITH.

WHEREAS, American Legal Publishing Corporation has completed its annual updating and revision of the Codified Ordinances of the City, and

WHEREAS, various ordinances of a general and permanent nature have been passed by Council since the date of the last updating and revision of the Codified Ordinances (December 31, 2022) and have been included in the Codified Ordinances of the City, and

WHEREAS, certain changes were made in the Codified Ordinances to bring City law into conformity with State law.

NOW, THEREFORE, BE IT ORDAINED by the Council of the City of Willard, Ohio:

Section 1. The editing, arrangement and numbering or renumbering of the following ordinances and parts of ordinances are hereby approved as parts of the various component codes of the Codified Ordinances of the City, so as to conform to the classification and numbering system of the Codified Ordinances:

Section 3. Pursuant to Article IV, Section 4.03, of the City Charter, copies of the 2024 Replacement Pages for the Codified Ordinances adopted herein shall be made available to the public in the Willard Memorial Library, in the Huron County Law Library, in the Huron County Court hearing chambers and in the Clerk of Council's office.

Section 4. All ordinances and resolutions or parts thereof which are in conflict or inconsistent with any provision of the new matter adopted in Section 2 of this ordinance are hereby repealed as of the effective date of this ordinance except as follows:

- (a) The enactment of such sections shall not be construed to affect a right or liability accrued or incurred under any legislative provision prior to the effective date of such enactment, or an action or proceeding for the enforcement of such right or liability. Such enactment shall not be construed to relieve any person from punishment for an act committed in violation of any such legislative provision, nor to affect an indictment or prosecution therefor. For such purposes, any such legislative provision shall continue in full force notwithstanding its repeal for the purpose of revision and recodification.
- (b) The repeal provided above shall not affect any legislation enacted subsequent to December 18, 2023.


Section 5. This ordinance is an emergency measure necessary for the immediate preservation of the public health, safety and welfare of the City of Willard, and for the further reason that it is immediately necessary to have an up-to-date Code of Ordinances with which to administer the affairs of the City, one that is consistent with the latest State law, as required by the Ohio Constitution, and provided it receives the affirmative vote of five-sevenths of all members of Council, it shall take effect and be in force immediately upon its passage.
